The long form of the showcase: the whole term's process, carrying the research, the iterations and the decisions behind what you presented. It follows the process-book convention you already know from the Design Cores, so the format needs no teaching. One thing does: a process book defaults to chronology, and chronology is the weakest possible version of it. What makes this worth reading, and worth marking, is the record of what you chose and what you rejected, with the reasoning. Organise it that way and the section headings do most of the work.
